


WE the undersigned, as the Juvenile Board of the 20th-82nd Judicial District,







This Agreement is entered into by and between the Milam County Juvenile Board, at the request of and on behalf of the 4M Youth Service, Inc. DBA Rockdale Regional Juvenile Justice Center (facility) a for-profit corporation, licensed to provide child care services by the Texas Juvenile Probation Commission, and/or any other appropriate State agency with licensure or regulatory authority over this facility.

ARTICLE I
PURPOSE

1.01 The purpose of this Juvenile Board Services Agreement is to provide 4M Youth Services, Inc. DBA Rockdale Regional Juvenile Justice Center with Juvenile Board Services in accordance with the Texas Family Code Section 51.12 and Section 51.125. The facility to be utilized is owned and operated by 4M Youth Services, Inc. and is located at 696 N. FM 487, Rockdale, Texas 76567.

ARTICLE II
TERM

- 2.01 The term of this Agreement is for 12 months, commencing December 12, 2007, and ending December 31, 2008. It shall be automatically renewed for one year terms thereafter, commencing January 1st and ending December 31st, unless one party notifies the other in writing, at least thirty (30) days prior to the expiration of said term, of its intention to not renew this Agreement.
- 2.02 The terms of this Agreement shall be extended until such time as all services which have been requested by Juvenile Board, and are pending on the termination date in section 2.01 above, have been performed.

ARTICLE III
SERVICES

3.01 Juvenile Board will provide the appropriate service as defined below:

A. Facility Approval




